LOCATION

The parade provides a good mix of multiple, regional and local retailers including Co-op, Lloyds Pharmacy, Corals, Spar, Pizza Go Go, Cinnamon Indian restaurant and a variety of other uses.

Located in the heart of the Gatwick Diamond, Crawley is a vibrant and growing town situated equi distant between London and Brighton with a current population of approximately 106,000, extending to over 160,000 persons within a 10kms radius.

A mid-terraced extended lock-up shop unit with a newly refurbished self-contained three bedroom maisonette above, situated in a popular neighbourhood parade to the south of Crawley town centre.
